- (iii) To run Rehabilitation Nursing Course.
- (iv) Minority Block area in Odisha may be earmarked and a proposal may be sent to the Ministry accordingly.
- (v) To start Parental Counseling Service at the Institute.
- (vi) Trauma Centre may be established in SVNIRTAR. A Detailed Project Report may be prepared.
- (vii) One of the Members Shri Bimal Jain proposed that the birth anniversary of Swami Vivekanand should be celebrated in letter and spirit in the Institute.

Shri R. Shiva, one of the Members of the General Council stressed upon to start Leprosy Rehabilitation Services at the Institute and the General Council made a note of it.
