

2. Item No. 118.2 may be approved.

3. **Item No. 118.1:-**

Ideally if any 100 bedded hospital is created, it should be immediately made operational to serve the mandate of the Ministry of Social Justice & Empowerment. Decision point should be how it serves the mandate of Ministry/Department rather than on profit solely. May provide clarification on Agenda Item No. 118.1 as follows:

- i. Why calculation is made on the basis of 50% occupancy of beds instead of 100%. If the asset is 100 bedded it should be utilized fully to avoid adverse audit comments.
- ii. Cost sheet is not clear regarding basis on which revenue is calculated.
- iii. On the expenditure side only manpower cost is calculated, there is no mention of equipment, consumables, fixed electricity, water and other charges.

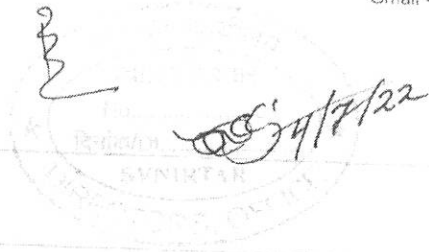
