**FOR SECOND COUNSELING CUM ADMISSION OF CET – 2017
SCHEDULED TO BE HELD ON DT.25.09.2017**

- I. The 2nd counseling cum admission of CET-2017 will be held on 25.09.2017 (Monday) to fill up seats remained vacant after 1st counseling held on 29.08.2017 to 31.08.2017 (3 Days).
- II. **Venue:** Swami Vivekanand National Institute of Rehabilitation Training & Research (**SVNIRTAR**), Olatpur, Bairoi, Cuttack, Odisha-754010.
- III. The following category candidates are instructed to attend the counseling in addition to the candidates called for 1st counseling.
 - a. **General – 714 to 914 ***
 - b. **OBC – 179 to 230**
- * The common rank No. 769 in General category bearing candidate name “Nandinee Priyadarshinee Jena” is ignored in the published 2nd Counseling Rank list of CET-2017, since the name has already been published in the 1st Counseling of CET-2017 Rank list bearing Common rank No. 700 in General category.
- IV. Who are eligible to appear in the 2nd Counseling :
 - a. All candidates, who were admitted / reported in the 1st counseling, held from 29.08.2017 to 31.08.2017 are **eligible**.
 - b. Candidates who did not appear in the 1st counseling are **not eligible** for 2nd counseling.
 - c. Candidates who are already admitted at SVNIRTAR, Cuttack / NILD, Kolkata/NIEPMD, Chennai through the 1st counseling of CET-2017 held on 29.08.2017 to 31.08.2017 are eligible to attend the 2nd counseling for interchange their Institution or Course only if seats are vacant as per combined rank list. No further request for change of Institution or Course will be entertained.
- V. The candidates will start to attend their classes after counseling cum admission as per the schedule, to be declared by SVNIRTAR /NILD /NIEPMD on the date of 2nd counseling.

VI. Seats are to be opened for fill up as per the information brochure.

VII. Method of Counseling :

a. Candidates from the categories namely General, SC, ST, OBC, NE States, PH and J&K will be called to fill up seats in these categories.

b. In case of non availability of reserved candidates the seat will be filled up with interchange between SC & ST category. Non availability of NE States, J&K and PH category candidates, the seats allotted for these categories will be converted & to be filled up in General category seats.
