**CORRIGENDUM**

In pursuance to Recruitment Notice Ref. No.: AD 6B 10/01/2023 dated 7<sup>th</sup> March, 2023 and further guidelines issued by the Ministry of Social Justice & Empowerment, Department of Empowerment of Persons with Disabilities, Government of India, vide letter F. No.: N-1306/3/2023-NI dated 04/05/2023 it has been decided that if any applicant has experience in the relevant area from any other National Institute under DEPwD in which recruitment is being made then SVNIRTAR shall consider to provide all benefits to that applicant which are being offered to contractual employees of SVNIRTAR, Cuttack i.e. age relaxation for the recruitment process by deducting the time spent in contractual employment in the Institute from the maximum age prescribed for the post applied for.

Further, age relaxation shall be applicable for departmental candidates for appointment to Group 'A', 'B', 'C' & 'D' posts as per Office Memorandum No. 35014/4/79-Estt (D) dated 21<sup>st</sup> October, 1985; OM No. 15012/8/87-Estt (D) dated 15<sup>th</sup> October, 1987 and OM No. 15012/1/88-Estt.(D) dated 20<sup>th</sup> May, 1988 of Department of Personnel & Training, Ministry of Personnel, Public Grievances & Pensions, Government of India.
