1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Aud Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover of relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than the average turnover in respect of the completed financial years after the date of constitution shall be taken into account.
2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or their OEM} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Org or Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening. Relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial years. In case of bunch bids, the category of primary product having highest value should meet this criterion.
3. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as per the procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notices by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier shall be as per the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM indicating the percentage of the local content and the details of locations at which the local value addition is made along with the bid. In case no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing

or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -Ind dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Nor as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will participate. In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same shall have precedence over this clause.

4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in the Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are not eligible for purchase preference under the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in case of offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected bidder) of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price. If price will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

6. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value. If number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA will be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

Extension shall be granted on an extraordinary course, except in Cases of any natural calamities, All India Transportation strike (with sufficient proof of the case of request of extension may be considered/allowed (subject to approval from Competent Authority) provided the request is received within the due date.
