3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goc Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid Services, the bidder must be the Service provider of the offered Service. 4. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowe participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1
