ANNEXURE - A: REQUIREMENTS & TERMS

- Cost for the services asked should be clearly specified including one time cost (if any) and annual cost along with GST (Refer BOQ given below).
- 2. Internet Service Providers has to ensure uninterrupted internet connectivity 24x7, with more than 99.5% uptime.
- 3. Any disruptions to be resolved on urgent basis, upon intimation via email/ phone/ letters.
- 4. There should be facility for future enhancement in internet speed, as and when required.
- 5. The contract shall be initially for two years, extendable further at same cost and terms upon mutual agreement.
- Internet connectivity shall be made available by the service provider inside the Server Room
 of the Institute, which shall then be distributed by SVNIRTAR to other departments through
 existing LAN. You will be required to demonstrate quality of service at site before
 commencement of contract.
- 7. One time cost, if any, shall be paid only once for item no.1 of BOQ after successful installation & activation of service at SVNIRTAR.
- 8. Annual cost shall be paid for the internet services, for item no. 2 and/ or 3 of BOQ depending upon services availed, on monthly/ quarterly basis, upon satisfactory execution of contract and submission of bill.
- Payment shall be released electronically approximately within 15 days after successful execution of contract as per terms, after receipt of bill and deduction of taxes at source, as per rules.
- 10. Should the service provider fail to provide service as per contract, the Institute shall be entitled at its option to cancel the Contract or a portion thereof anytime without any prior intimation in this regard. The decision of the Institute in this regard shall be binding on the service provider.

11. Settlement of disputes:

- a) If disputes or differences of any kind whatsoever arising out of or in connection with the contract, shall be referred by the Service provider to the Director, SV.NIRTAR. The decisions of the Director shall be binding on the contractor.
- b) In case the Service provider is not satisfied with the decision of the institute on any matters in question, dispute, or difference to be submitted upon shall be referred for decision to the Executive Council of SVNIRTAR, whose decision shall be final and binding on the Service provider.
- c) The court of Cuttack only will have jurisdiction to deal with and decide upon any legal dispute what so ever arising out of this tender.
