1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of financial year, should be as indicated above in the bid document. In case the date of constitution / incorporation of the bidder is less than 3-year turnover in respect of the completed financial years after the date of constitution shall be taken into account for this 2. - 3. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as a procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/No concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplied bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OE percentage of the local content and the details of locations at which the local value addition is made along with their no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to procure to shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) on 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allow case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedure.
- 4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purche bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contrawarded for 25%(selected by Buyer) percentage of total QUANTITY.
- 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment reasonableness and based on competitive prices received in Bid / RA process.
- 6. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chose amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM at for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would k at least products of one more OEM (directly participated or through its reseller) if available.
